

BetterLife's Online Terms of Use

Welcome, these Online Terms of Use govern access to and use of BetterLife's websites, various online services operated by or on behalf of BetterLife, as well as the related content made available through the websites or online services (each website or online service being referred to hereafter as the "Site").
